<u>LET US MEET IN</u> PURI, ODISHA

Our CHQ informs that the 21st All India Conference of NUR C union will be held at Puri Odisha from 1stNovember to 3rd Novmber 2017. This is an important conference for RMS and MMS employees.

The NDA Government rejected all our genuine demands in 7th CPC. We were betrayed by their decision.

Mail volume is declining every year, probably it might be a Global trend but in other countries E-commerce business has increased many folds, in India, it is not so. This has resulted in decrease in revenue.

We are receiving bags through BPC, BNPL and not from the Post office. Volume of bags have increased in TMOs. It appears that we are getting more mails from public but the real picture is different.

Directorate fixed norms for CRC & Speed post, but no mail offices are following the norms. All the officials working in CRC & Speed Post are suffering, and publics are not getting mails in time.

Recruitment is taking place as per the annual recruitment plan from 2008 without any reduction of posts, but mail offices are functioning with acute shortage of manpower Why this contradictory?

MMS cadre restructuring has been finalised and sent to the DOP&T a year back and we have not got any reply from the Department.

Gazette Notification for MMS Cadre recruitment rules have not yet been published. Draft Recruitment Rules are made to toss from one table to another and one Department to another for the last four years. Constant pressure from us did not yield any result.

Our demand for cashless treatment for Central Government employees is only in paper. Health Ministry did not take steps to implement.

The policy of the government is totally against the working class community. Central trade unions are unable to Stop outsourcing in the Government sector.

Above, all senior colleagues are to retire shortly and it is high time to introduce young leader to lead our organisation.

To find out solutions for all the above issues, we are assembling in Puri Odisha during November 2017.

CHQ appeals to all our colleagues to conduct a General body meeting in their place discuss the above issues come with a clear solution your decision is final, let us meet in Puri Odisha from 1/11/2017 to 3/11/2017.

OFFICE MEMORANDUM

Subject:- Payment on account of discontinued allowances – regarding.

The undersigned is directed to inform that the recommendations of the 7th CPC on allowances have been accepted by the Government with 34 modifications

- 2. In this regard, attention is drawn to Para 8.2.5 of the Report of the 7th CPC wherein it has been mentioned that any allowance, not mentioned in the Report (and hence not reported to the Commission), shall cease to exist immediately. In case there is any demand or requirement for continuation of an existing allowance which has not been deliberated upon or covered in this report, it should be renotified. by the Ministry concerned after obtaining due approval of Ministry of Finance and should be put in the public domain.
- 3. As the recommendations of the 7th CPC on allowances have come into effect from 1st July, 2017, disbursement of all existing allowances which have not been specifically recommended for continuation in terms of the Resolution dated 6th July, 2017 shall be discontinued from the salary of the month of July, 2017.
- 4. In view of the nature of the Allowances specific to Ministry of External Affairs, these allowances were not covered by the 7th Central Pay Commission, Hence this order will not be applicable to allowances specific to Ministry of External Affairs.
- 5. It shall be the responsibility of the Heads of the Department to ensure that no bills relating to disbursement in respect of such allowances is drawn by the Head of Office/Drawing Disbursing Officers under their purview/jurisdiction. Pay and Accounts Officers shall ensure that no payment is effected if any such bill relating to the disbursement of the discontinued allowances is submitted to them. If such bills are received, they should be

returned to the DDO and intimation thereof shall also be given to the Head of the Department and the Chief Controller of Accounts.
