**Subject: Request for creation of Rewari Division by bifurcating Bhiwani and Gurgaon Divisions instead creation of Division Office at Narnaul-reg.**

We, the stake holder union wish to express our serious concern regarding the recent proposal from Circle Office Ambala for the creation of a new Divisional Office at Narnaul. We believe that this proposal does not reflect the practical ground realities and appears to be influenced by personal preferences rather than objective departmental needs. Such an important decision should be made considering long-term administrative efficiency, staff welfare, public convenience, infrastructure, and scope for future growth. The following points are submitted in support of our request:

**Superior Rail and Road Connectivity:**

Rewari is a major railway junction, well-connected to Delhi, Jaipur, Mumbai, and other key cities, with direct train and bus services. The city is also linked by multiple national highways, providing easy and fast access for both postal staff and the general public.

**Central and Accessible Location:**

Geographically, Rewari is centrally located and offers better accessibility for most surrounding regions. This would reduce travel time and expenses for staff and allow for smoother operational coordination across the division.

**Better Infrastructure Availability:**

Rewari already has adequate government infrastructure, departmental buildings, staff quarters, and better urban facilities. In comparison, Narnaul lacks similar infrastructural readiness, which could delay the establishment and increase setup costs.

**Expanding Industrial and Commercial Base:**

Rewari is rapidly developing as an industrial hub, with regions like Bawal and nearby IMT Manesar boosting economic activity. This translates into greater postal traffic and business potential, justifying the presence of a Divisional Office.

**Proposal for Upgrading Rewari MDG:**

A proposal is already under consideration for upgrading Rewari MDG to a Head Post Office. This indicates the department's recognition of Rewari's strategic importance, and establishing a Divisional HQ here would be a logical extension.

**Staff Convenience and Public Benefit:**

A considerable number of postal staff reside in or around Rewari. Locating the Divisional Office here would ease commuting, improve morale, and ensure faster and more reliable service to the public in nearby areas.

**Administrative Efficiency:**

Due to better communication infrastructure and road links, Rewari would offer smoother coordination with sub-divisions and field offices, leading to more efficient divisional administration.

In view of the above all reasons, my Federation requests your authority to consider the demand of Rewari as HQRs for the proposed new postal division of Rewari only instead of Narnaul.
