## COMMON O R D E R

# Per: Justice Sunil Thomas, Judicial Member -

All the applicants herein were engaged under the respondents Postal Department, either as Postal Assistant or as Postmen. All of them were appointed towards the vacancies that arose in 2002, by a selection process pursuant to a notification issued by the respondents. It is seen that vacancies

were approved by the Department of Post by notification dated 18.9.2003. The applicants responded to the vacancy notification and in the selection process they were successful and they were appointed after 1.1.2004. In the mean while the National Pension System was brought into force with effect from 1.1.2004. While so, representations were submitted by various employees' organization contending that some of them were successful in the selection process conducted prior to the introduction of the National Pension System and they were entitled to the benefit of the old pension scheme. Accordingly, notification was issued by OM dated 17.2.2020 giving one time option to Central Government employees who were declared successful for recruitment in the results declared on or before 31.12.2003 against vacancies which occurred before 1.1.2004 and were covered under the National Pension System on joining on or after 1.1.2004 to be covered under the CCS (Pension) Rules, 1972 [now 2021].

2. Thereafter, further representations were received for extending the benefit of pension scheme on the ground that their appointments were made against post/vacancies advertised/notified for recruitment prior to the notification of the National Pension System. Accordingly, a notification dated 3.3.2023 was issued extending benefit of the old pension scheme and giving a one-time option to all those persons covered by paragraph (4) of the

said notification dated 3.3.2023.

- 3. The applicants claiming that though each of them was appointed after 1.1.2004, the selection process was towards vacancies notified prior to 1.1.2004 has approached the Postal Department seeking the benefits. All the representations were rejected on the premise that all of them were appointed after 1.1.2004.
- 4. Aggrieved by the rejection of their claim for inclusion in the old pension scheme, the applicants have approached this Tribunal. Some of the applicants are still in service, while others have retired.
- 5. Respondents filed separate reply statements in the OAs commonly contending that the applicants were appointed by the respondents after 1.1.2004. Since the notification was issued by the PMG, Kerala on 5.1.2004 and the applicants were selected and they had joined the service after 1.1.2004, they were covered under the National Pension System (NPS). It was also contended that the benefits of the OM dated 3.3.2023 cannot be extended to the applicants since the selection process was completed after 1.1.2004. Accordingly, their request for bringing them under the benefit of old pension scheme was rightly rejected.
- 6. Heard both sides and examined the records.

7. Admittedly, the notification 12-2/2002 of Trivandrum was issued by the Office of Chief Postmaster General of Kerala Circle, Trivandrum on 05.01.2004 for conducting of examination for recruitment to the cadre of Postman/Mail Guard for the year 2002. The National Pension System was notified on 22.12.2003. Thereafter, OM dated 03.03.2023 was issued by the Ministry of Pension & Pensioners' Welfare regarding the coverage under Central Civil Services (Pension) Rules in place of National Pension System, of those Central Government employees who were recruited against posts/vacancies advertised/notified for recruitment, on or before 22.12.2003. The crucial part of the said OM is seen at paragraph 4, which is extracted as follows:

".......It has now been decided that in all cases where the Central Government civil employee has been appointed against a post or vacancy which was advertised/notified for recruitment/appointment, prior to date of notification for National Pension System i.e. 22.12.2003 and is covered under the National Pension System on joining service on or after 01.01.2004 may be given a one-time option to be covered under CCS (Pension) Rules, 1972 (2021)......"

The cut-off date for exercising the option was also provided.

8. Accordingly, all the applicants had opted to switch over to the old pension scheme which were rejected by the respondents on the premise that all the applicants have joined the Postal Department after 01.01.2004.

- 9. The short question that arises in all the Original Applications, is whether each of the applicants who has been appointed after 01.01.2004 is appointed against "a post or vacancy which was advertised/notified for recruitment/appointment prior to the notification of National Pension System i.e. 22.12.2003".
- 10. In this regard, to buttress the legal point involved, the learned counsel for the applicants invited my attention to a few decisions in which the same issue has been the subject matter. In OA No. 649/2015, this Tribunal had found that the applicant was appointed as a Postman on 26.06.2004. On facts, it was found that the vacancy had arisen prior to 2004. Records indicated that he was appointed against a vacancy which arose in the year 2002 and that the vacancy was notified prior to 01.01.2004. Accordingly, it was held that the applicant was entitled to the benefit of OM dated 03.03.2003 and accordingly, it was allowed. Though it was subjected to challenge in OP (CAT) No.197/2017, the OP (CAT) was disposed of confirming the order of this Tribunal.
- 11. Another matter that came up for consideration was in OA No. 207/2024 *E. Parmeswaran* v. *Union of India*. In that case, the applicant was appointed as a Postman on 26.06.2004. The proceedings for the Department Promotion Committee, which recommended for the

appointment of the applicant was produced as Annexure A2 in that OA. It was noticed that a communication was issued by the Assistant Director, Staff dated 10.12.2003 with reference to RECT/9-2/2002 addressed to all SSPOs, SPOs. It related to optimization of direct recruitment in civilian post. It stated that the number of posts approved by the Screening Committee for filling up in the region in Postman and Group D cadres for the year 2002 have been apportioned as mentioned therein. It was stated that the Chief PMG had ordered to initiate the recruitment process in respect of Group D to be completed by 31.12.2003. The DPC was held on 25.05.2004 for selection to the cadre of Postman from the GDS on the basis of seniority-cum-fitness. It was found that the applicant was appointed against the vacancy of Postman, which was notified for appointment prior to the notification dated 22.12.2003. Hence on facts, the OA was allowed and the applicant therein was ordered to be granted the benefit of OM dated 03.03.2003.

12. It seems that the order was implemented. The respondents did not even challenge that order. A copy of the proceedings in MA No.1063/2024 in OA No.207/2024 was produced by the applicants. It shows that on 13.06.2025, it was recorded by this Tribunal that ACGSC submitted that the PPO was issued.

- 13. In the OAs herein, the factual situation is almost identically same as in earlier referred OAs'. The applicants placed reliance on the communication issued by the Department of Posts from the Assistant Director General, SPN signed on 18.9.2003 addressed to all Principal Chief Postmaster Generals. It was stated therein that earlier all circles were requested to furnish a report covering the requirements of various cadres for formulating the annual direct recruitment plan in respect of Groups B, C and D posts for 2002. Based on the recommendations of the screening committee 2150 vacancies which were to be filled up through direct recruitment for 2002 have been allocated to the circles as per the enclosed statement. It was directed that respondents shall not change the allocation since it was apportioned on the basis of the feed back from the various circles. Accordingly, the Postmaster Generals were directed to fill up the vacancies. As per the statement enclosed along with the communication 107 vacancies of PA and 18 vacancies of Postmen were identified for the Kerala circle. A copy of the file notings there pursuant to the above OM is placed on record in few OAs. It was obtained under the Right to Information Act.
- 14. Pursuant to the above notification, examination for recruitment to both the categories in common were to be held on 22.2.2004. It was proposed that an officer of DPS may be nominated to set up the question paper. The first

noting is dated 15.12.2003. Thereafter, selection process was set into motion and examination was conducted. Evidently, the notification for recruitment had commenced prior to 1.1.2004.

These facts clearly show that the posts were identified and were notified. 15. In OMdated 3.3.2023 both the terms "advertised/notified recruitment/appointment" are used. In the light of both the terms available in the OM it is clear that both cannot have the same meaning and are not synonymous to each other. In normal parlance, "advertised" refers to a public announcement for vacancies usually in a newspaper, that invites applications, while "notified" indicates a formal, often statutory or rule based declaration that a vacancy exists providing a legal basis for the recruitment process. Advertisements are a method of communicating vacancies to a broad audience to ensure transparency, whereas notification is a formal act by an authority to inform public or specific bodies about something significant, like a deemed vacancy. Thus, advertisements are public announcement, often through newspapers or other media, that details the number of posts, eligibility criteria etc. On the other hand, notifications are formal communications often issued as a statutory rule that serves as the legal basis for action. Evidently, advertisement is published for public information and the notification can be for official purpose for initiating the process of recruitment and should necessarily precede the advertisement. Evidently, in this case the posts have

been notified for recruitment for the year 2002. Though the entire process was completed and the applicants appointed after 1.1.2004, evidently, they were appointed against vacancies notified for recruitment. This view seems to be in consonance with the earlier view of the Tribunal. The claim of applicants to that extent is liable to be allowed.

16. In the light of the above finding the OAs are only to be allowed granting them for the purpose of pension, the benefit of OM dated 3.3.2023. Appropriate orders shall be passed in relation to the retired employees bringing them under the coverage of the old pension scheme. In the case of serving employees also fresh orders shall be passed bringing them under the coverage of the old pension scheme and consequential orders passed therein. Both orders shall be passed within three months from the date of receipt of a copy of this order. The entire amount due to the applicants who have already been retired shall be paid within a period of one month thereafter. If the entire amount is not paid within the above total of 4 months in the case of retired employees, the amount due will carry 9% interest till it is paid.

17. OAs are allowed to the above extent. No order as to costs.
