Subject : Agitation by NUGDS alongwith other GDS Unions (JCA).

Dear colleagues,

As you all are aware that after an unprecedented **Strike conducted by NUGDS Unions** along with all other GDS Unions in the month of July, 2018 the Central Government Cabinet and Department of Posts have implemented a portion of **Shri Kamlesh Chandra Committee Report** but neglected the **genuine and beneficial portions** of the Report. In view of the above on 06.09.2018, all GDS **Union General Secretaries met at Delhi** to discuss and finalize the future course of action for bringing notice of the Government of India and Department of Posts for acceptance and implementation of the report in toto. They have decided the following countrywide agitation program:-

1. **25.09.2018** : One day hunger fast in front of Divisional Offices
2. **04.10.2018** : One day hunger fast in front of Circle Offices
3. **10.10.2018** : One day massive hunger fast in Delhi

The Charter of Demands and formal notice for the **Agitation Program** will be by the General Secretary, NUGDS and other GDS Unions jointly (JCA) as per rules.

In this connection we may recall that during the last strike we have extended solidarity to the **agitation** and expressed our concern about **non-implementation of Shri Kamlesh Chandra Committee Report** which resulted a big success. As you all know the participation of GDS Staff in all agitations by the Federation at all times with whole heartedness that lead the Department to grant various kinds of benefits to the Departmental Staff and GDS Staff as well.
