Subject: Creation of a new Region named "**Jabalpur Region**" at Jabalpur, Madhya Pradesh Circle by re-organizing the existing Regions


The president is pleased to create a new Postal Region named "**Jabalpur Region**" at Jabalpur, Madhya Pradesh Circle by re-organizing the existing Regions i.e. HQ Region Bhopal and Indore Region

2. The Headquarters of Jabalpur Postal Region will be at Jabalpur, Madhya Pradesh and will be accommodated at Head Post Office, Jabalpur. The Chief Postmaster General, Madhya Pradesh Postal Circle will issue necessary orders after ensuring the arrangements to setup Jabalpur Postal Region.
3. The jurisdiction of Jabalpur Postal Region is shown at Annexure-I. The jurisdiction of other two Regions i.e. HQ Region Bhopal and Indore Region are shown at Annexure-II.
4. The Establishment of Regional Office at Jabalpur is approved as proposed by the Madhya Pradesh Circle vide their letter No. Estt/10-59/Jabalpur Region dated 30.12.2016. Necessary orders for redeployment/transfer/diversion of posts will be issued separately by the concerned Divisions of Postal Directorate and by the CPMG, Madhya Pradesh Circle.


