Subject: Order(s) dated 19.04.2023 of Hon'ble CAT, Bengaluru Bench passed in OA Nos. 553/2020 (filed by Shri Vijaykumar S. Emmegol) and 554/2020 (filed by Shri Allasab) and subsequent Order dated 12.01.2026 of the same Bench in Contempt Petition (CP) Nos. 38/2023 and 39/2023 - Implementation thereof – regarding.

Sir,

I am directed to refer to the subject cited above and this office letter No. A-34013/01/2020-DE dated 13.11.2020, whereby the revised and recast results of LDCE (66.66%) for promotion to the cadre of Inspector Posts for the years 2016-17, 2017-18 and 2018, held on 16th-17th November, 2019, were declared.

2. Hon'ble CAT, Bengaluru Bench vide order (common) dated 12.01.2026 in CP No. 38/2023 and 39/2023 directed the Department to report compliance of their original Orders dated 19.04.2023 passed separately in OA Nos. 553/2020 and 554/2023, subject to the outcome of the Review Petition (C) diary No. 70195/2025. The operative part of the ibid Orders dated 19.04.2023 is reproduced here as under:

"The respondents No.1 & 2 shall issue promotional order to the applicant for the post of Inspector of Posts based on the applicant's selection of results declared vide Endorsement issued by Chief Post Master General, Karnataka Circle dated 26.06.2020 vide Annexure-A1, by creating a supernumerary post, if required, but his name shall figure at the bottom of the list of selected candidates prepared on the basis of the second revised results declared on 13.11.2020.

The appointment/promotion of the applicant shall relate back to the date when the applicant was first promoted with continuity of service, for the purpose of seniority but without any back wages or arrears of salary or other incidental benefits."

3. The facts, records of the cases, and the Orders passed by Hon'ble CAT in the matter, have been examined. The Competent Authority has decided to implement the directions contained in Hon'ble CAT's Orders dated 19.04.2023 passed in OA Nos. 553/2020 (filed by Shri Vijaykumar S. Emmegol) and 554/2020 (filed by Shri Allasab) with a rider that this compliance is exclusive and cannot be quoted or referred to in any other matter, treating as a precedent. The



implementation is further subject to the outcome of the Review Petition (C) diary No. 70195/2025, which is pending before the Hon'ble Supreme Court of India.

4. Accordingly, the results of Shri Vijaykumar S. Emmegol and Shri Allasab, Karnataka Circle are hereby declared treating both the applicants as "Selected" against the existing vacancies / vacancies arising in future for the year 2018. Their names are placed below the bottom of the list of selected candidate (Annexure –III of letter dated 13.11.2020) of Karnataka Circle. The details are as under:



5. The promotion orders shall be granted strictly in accordance with the Hon'ble CAT's order dated 19.04.2023. The appointment/promotion of the said candidates shall relate back to the date when the candidates were first promoted with continuity of service, for the purpose of seniority but without any back wages or arrears of salary or other incidental benefits.

6. Circle / Personnel Division, while issuing necessary promotion orders in respect of both the above said candidates, shall ensure that the officials are clear from vigilance angle in terms of the extant instructions on the subject.


