**Subject: Formulation of AIP Calendar 2025-26 and tentative allotment of funds for events – reg.**

Respected Madam/Sir,

This is w.r.t to formulation of Annual Postal Sports Calendar for the year 2025-26. The Postal Sports Board generally conducts 13 sporting events and a cultural meet in each financial year. However, previously, multiple events were cancelled as demands of funds required by Postal Circles to host the said events could not be fulfilled by Postal Sports Board due to paucity of funds. To avoid cancellation of events at a later stage, it has been decided that limited number of AIP tournaments would be conducted based on available funds.

2. In this regard, AIP sporting events (except Cultural Meet) would be conducted biennially until the paucity of fund remains. Therefore, only those AIP sporting events which were not conducted in the last FY (2024-25) shall be conducted in this year (2025-26) along with Cultural Meet. List of events to be conducted is attached at annexure A.

3. In this financial year, considering efficient utilization of funds and for smooth conduct of AIP tournaments, it has also been decided to fix event-wise maximum amount, that, will be allocated by Postal Sports Board to Circles, for conducting the events mentioned in annexure A. Further, maximum amount of **Rs. 7 lakhs for participation/nomination** of teams/other expenses in AIP tournaments shall be allotted to each circle (to host Circles also in addition to fund for hosting). Funds however, shall be allocated only after receipt of F&C audited Accounts as per established procedure.

4. Based on above, Circles are requested to **provide willingness** for hosting AIP events as mentioned in annex. B **while taking into account maximum allotments** mentioned in annex. A.

5. All the Postal Circles are hereby requested to provide willingness for the AIP events as mentioned in annexure B by 30.04.2025 positively.

6. This issues with the approval of Competent Authority.
