Subject: Request to declare the results of P.S Group 'B' Exam held on 04.06.2023 - Reg

Ref: 1. My Federation letters dtd 29.12.2023, 15.03.2024 and 30.09.2024

2. Directorate letter No 09-04/2024/SPG-II dated 01.02.2024

In continuation of my Federation letters cited above on the mentioned subject, the following is submitted herewith for your kind intervention in early declaration of results of P.S Group 'B' Exam held on 04.06.2023.

2. It was already brought to your kind notice through my Federation letter dated 30.09.2024 that the Hon'ble CAT, Ernakulam Bench had set aside the Directorate letter No F.No A-34012/04/2023-DE(I) & (II) dated 21.11.2023 and directed the Department to publish the results and complete the process within a period of 60 days *vide* order dated 27.09.2024 in OA No 604/2023. Further, it is learnt that the Department had filed Review Petition based on the contradictory order given by the Bengaluru Bench of Hon'ble CAT in the same matter and hence the Ernakulam Bench had referred the matter to Principal Bench, New Delhi and the Principal Bench had constituted Full Bench consisting of 3 different members from 3 different Benches i.e Bengaluru, Ahmadabad and Hyderabad.

3. Accordingly, the Full Bench had heard the matter afresh in depth and given its decision in favour of the applicants again *vide* order dated 09.10.2025 and concurred with the order dated 27.09.2024 of Ernakulam Bench. The following are the major observations of the Full Bench.

a) The Full Bench had mainly examined the Question of Law referred to it i.e applicability of Junior - Senior Clause to the P.S Group 'B' Exam held on 04.06.2023 and decided that the said Clause is not applicable to the instant case as it is not included in the Statutory Recruitment Rules.

b) The Rules of the Game should not be changed after it has already been played as per the latest judgments of Hon'ble Apex Court. Therefore, the exam should not be cancelled after the same has been conducted with the eligibility criteria mentioned in the Statutory RRs that to after taking a concise decision of not including the Clause in the Notification dated 02.01.2023.

4. In view of the above, My Federation requests the personal intervention of Hon'ble Secretary Madam in the following points to do justice to the innocent candidates, who prepared well for the exam by sacrificing their time, energy and money and eagerly waiting for declaration of the results.

a) To declare the results by cancelling the candidature of irregularly admitted candidates, if any as per the instructions specified at Serial No 9 of Admit Cards.

b) To declare the results immediately without waiting for receipt of formal orders from the Hon'ble CAT as the order dated 09.10.2025 of Full Bench was already available in public domain in the Hon'ble CAT Website and the Directorate itself issued orders *vide* letter No 99-11/2017-LC dated 28.06.2017 to comply with the Hon'ble Court orders in a timely manner by keeping track of Court orders from respective court websites without waiting for receipt of formal orders.

c) To issue notional seniority to the selected candidates from eligible date as per order dated 07.03.2024 of Hon'ble CAT, Ernakulam Bench in MA No 188/2024 in OA No 604/2023.

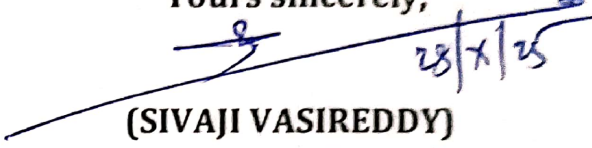
d) To complete the process of declaration of results on or before 31.12.2025 so that the selected candidates can join on or before 01.01.2026 to get the fixation benefit as they already lost so much of benefits due to delay in conducting the exam from the year 2021 and due to delay in declaration of results on account of various factors.

e) It is also learnt that the promotions to the cadre of P.S Group 'B' through DPC mode are also being delayed due to the order dated 26.09.2025 of Hon'ble CAT, Bengaluru Bench in OA No 8/2023. As the promotions through both LDCE and DPC were stalled, it is high time to implement the Full Bench order and declare the results of the LDCE held on 04.06.2023 to fill at least some of the P.S Group 'B' vacancies at this crucial juncture of implementation of various policy decisions and I.T 2.0 by the Department and also it is requested to cause to take immediate action to issue fresh LDCE notification for the years 2024 and 2025, which will benefit the LSG/HSG officials.

5. Therefore, my Federation requests the kind authority to review all the aspects involved in the issue afresh and implement the order dated 09.10.2025/ 27.09.2024 of Full Bench/ Ernakulam Bench of Hon'ble Tribunal and cause to declare the results of the LDCE for promotion to the cadre of PS Group 'B' already held on 04.06.2023 and promote the successful candidates with all consequential benefits as per the above orders, by simultaneously cancelling the Notification dated 21.11.2023 and cause to do justice to all the aspirants.
